A RESOLUTION OF THE BOARD OF DIRECTORS OF THE MIAMI-DADE COUNTY LEAGUE OF CITIES, INC., SUPPORTING THE MIAMI-DADE COUNTY SCHOOL BOARD'S LEGISLATIVE PLATFORM.

WHEREAS, the Florida Constitution provides that the education of children is a fundamental value of the people of Florida and a paramount duty of the state; and

WHEREAS, the Board of Directors of the Miami-Dade County League of Cities believes that funding a high-quality education system is an investment in our state's and our community's ability to compete nationally and globally in the marketplace; and

WHEREAS, the Board of Directors of the Miami-Dade County League of Cities believes that adequate funding is needed to achieve a high-quality education system measured by gains in student achievement.

NOW, THEREFORE,

BE IT RESOLVED by the Board of Directors of the Miami-Dade County League of Cities, Inc.:

Section 1. The Board of Directors of the Miami-Dade County League of Cities supports Miami-Dade County Public Schools' legislative initiative and requests that the Florida Legislature:

- Fulfill its commitment to hold school district operational and capital funding harmless from the impact of property tax reform and budget shortfalls by funding the student enrollment at minimally 2008-2009 levels of \$6,968.29;
- Restore the local Discretionary Capital Outlay levy to 2-mills; and
- Oppose legislation that reduces the number of in-service hours required of teachers providing instruction to English Language Learners.

Section 3. The Board of Directors of the Miami-Dade County League of Cities requests the Florida Legislature to create an independent line-item budget/ funding to address teacher salaries with no negative impact on pre-existing programs.
