# **March BOD meeting**

On March 5, 2015 the MDCLC held a Board of Director's meeting at the Melresse Country Club. The meeting was well attended. Various topics were discussed such as the Metropolitan Planning Organization (MPO), the Lancelot Jones Day Resolution, MDCLC Resolution No. 2015-1 and Age friendly Initiative.

<u>MPO</u>: A motion was passed by a unanimous vote by the Board of Directors to endorse in concept a change of the MPO structure.

Lancelot Jones Day: Vice Mayor Stephen Shelley, City of Homestead, introduced the Lancelot Jones Day Resolution and requested the support of the MDCLC for the establishment of a perpetual Lancelot Jones Day in the State of Florida. The Lancelot Jones Day Resolution was included in the BOD agenda, and the motion passed by a unanimous vote.

#### **MDCLC Resolution No. 2015-1.**

A RESOLTION OF THE MIAMI-DADE COUNTY LEAGUE OF CITIES URGING THE MIAMI-DADE COUNTY BOARD OF COMMISSIONERS TO PROTECT THE COUNTY FROM SEA LEVEL RISE BY MOVING, INTO ACTION, THE RECOMMENDATIONS OF THE SEA LEVEL RISE TASK FORCE.

Motion passed by a unanimous vote.


